Eligibility (Age limit): Only Odisha born players on or after 01st Jan'2010.

AOCA Registration: AOCA registration is compulsory for all the players for the current year 2019-2020. For new players by paying Rs.150/- along with duly filled AOCA registration form, Birth Certificate n one passport Size Photograph.

Birth Certificate n Birth Registration: Participants whose date of birth is not registered within one year of Date of Birth will only be allowed to participate in this State tournaments but his/her name will not be forwarded for National Championship until unless he/she clears the medical test by AICF.

System of Play: The Championship will be played as per FIDE's Laws of Chess n FIDE Swiss System with Max (7) rounds to be played.

Session/Time Control: The rate of play shall be 45 minutes with an increment of 30 seconds per move from move no.1

Tie Break: 1) Direct Encounter, 2) Buchholz Cut-1, 3) Buchholz 4) Sonneborn Berger 5) The greater no of wins (forfeit included)

Protests: Protest, if any, against the decision of the Chief Arbiter shall be made in writing with a protest fees of Rs.700/- within 15 minutes of the occurrence of the incident. The protest fee will be refunded if the appeal is upheld.

State Qualifiers: The top (2) players from Open n Girls section will be selected to represent "Odisha" State in the forthcoming National (U-9) Open n Girls Chess Championship-2019 to be held at Ahmedabad (Gujrat) from 03rd-11th Aug'2019.
