#### **TOURNAMENT RULES**

System of play -The Tournament will be conducted as per FIDE laws of Chess & FIDE Swiss system with 7 rounds.

Time control -60 minutes plus 30 secs increment from move no 1 for the entire game.

Tie Break -In case of a tie, the latest FIDE rules shall come into effect. The cash prizes however, will not be shared.

Default Time -The default time will be 30 minutes. Electronic Devices -All Electronic devices including wrist watches (all types of watches) are not allowed in the tournament hall.

Withdrawal -A player may withdraw at any stage of the event after informing Chief Arbiter in writing.

Appeal Committee - Before the commencement of the Tournament, an Appeal Committee will be formed. The decision of the Appeal Committee will be final.

Protest- Protest, if any, against the decision of the Chief Arbiter should be in a writing with a protest fee of 500/-within 15 minutes of the occurrence of the incident to the Appeal Committee.
