- 5. System of Play: The Tournament will be conducted as per FIDE's Laws of Chess and FIDE Swiss System with 8 rounds.
- **6.** TimeControl: 45 minutes with 30 seconds increment from move no.1
- 7. Draw Offer: Players shall not agree for a draw without the consent of the arbiter, before each player makes 20 moves.
- **8. Tie- Break**: The cash prizes however will not be shared. The following tie-break will be followed:
 - (a) BuchhlozCut1
 - (b) Buchhloz
 - (c) Sonneborn Berger
 - (d) Direct Encounter
 - (e) The greater number of wins
- **9.** Protest: Protest if any, against the Chief Arbiter, should be made in writing with the protest fee of Rs.1,000/-within15 minutes of occurrence of the incident. The protest fee amount shall be refunded if the Appeal is upheld and if not then protest fee shall be forfeited.
- **10.** Appeal Committee: Before commencement of the tournament, three Members Appeal Committee shall be formed. All members and the reserves shall be from the different districts. No member of the Committee can vote on a dispute in which a player from his own district is involved and, in such case(s) the reserve member(s) shall take his place in the committee. The decision of the appeal committee is final and binding to all players concerned.
- **11. Disqualification**: No player shall leave the venue before the prize distribution function without the permission of the Chief Arbiter.

- **12.** Electronic Devices: All electronic items including wristwatches (all type of watches) are not allowed inside the tournament hall during the match. Those who are found having mobile phones or wearing watches during their play will be declared lost.
- 13. State Qualifiers: Top two (2) boys & girls each will qualify for the upcoming 37th National U-11 Chess Championship 2024 to be held at "Hyderabad" from 04th October 2024 to 10rd October 2024.
