2. **Entry Registration:** Interested players can enroll their name

(i) By paying Entry fee **INR 600/-**(Rupees Six hundred only) (Non-refundable) through **QR Code**.

(ii) After payment respected player must share the payment screen short (with transaction ID) along with his/her Name, FIDE ID, Date Of Birth, Gender, Mobile/Whattapp No and Distct name to Mr. S. K. Bisoi's WhatsApp No. that is **9583086627**

5. **System of Play:** The Tournament will be conducted as per FIDE's Laws of Chess and FIDE Swiss System with 7 rounds.
6. **Time Control:** 60 minutes with 30 seconds increment from move no.1
7. **Draw Offer:** Players shall not agree for a draw without the consent of the arbiter, before each player makes 20 moves.
8. **Tie-Break:** The cash prizes however will not be shared. The following tie-break will be followed:
- (a) Buchhloz Cut-1
 - (b) Buchhloz
 - (c) Sonneborn Berger
 - (d) Direct Encounter
 - (e) The greater number of wins
9. **Protest:** Protest if any, against the Chief Arbiter, should be made in writing with the protest fee of Rs.1,000/-within 15 minutes of occurrence of the incident. The protest fee amount shall be refunded if the Appeal is upheld and if not then protest fee shall be forfeited.
10. **Appeal Committee:** Before commencement of the tournament, three Members Appeal Committee shall be formed. All members and the reserves shall be from the different districts. No member of the Committee can vote on a dispute in which a player from his own district is involved and in such case(s) the reserve member(s) shall take his place in the committee. The decision of the appeal committee is final and binding to all players concerned.
11. **Disqualification:** No player shall leave the venue before the prize distribution function without the permission of the Chief Arbiter.
12. **Accommodation:** FREE Dormitory accommodation will be allotted for out stationed players only on prior intimation before 15th October by 5 pm.

13. **Electronic Devices:** All electronic items including wrist watches (all type of watches) are not Allowed inside the tournament hall during the match. Those who are found having mobile phones or wearing watches during their play will be declared lost.

14. **State Qualifiers:** Top four (4) Qualifiers from open & girls each will be selected to Participate in the upcoming **National U-15 Chess Championship - 2024 to be held at "Hosur,Tamilnadu" from 3rd November 2024 to 11th November 2024**
