## **Tournament Rules:**

**Eligibility:** Only Women players from the state of Odisha are eligible to participate in this Championship.

**System of play:** The Tournament will be played as per FIDE laws of Chess and FIDE Swiss System with 7 rounds.

**Time Control:** 45 minutes plus 30 seconds increment from move 1 for the entire game.

**Tie Break :** The following Tie-breaks will be applied.

1.Buchholz Cut-1    2.Buchholz    3.Sonne born-Berger4.Direct encounter

**Default Time:** The default time will be 20 minutes.

**Mobile Phone n Wrist Watches:** Mobile phones and all electronics devices including wrist watches (all type of wrist watches) are not allowed inside the tournament hall. Players may keep it in separate bag with switched off mode. If the same found during the game in person, players are liable to lose the game or his/her game will be treated as lost (Article: 11.3.2).

**Draw offer:** No draw offer will be allowed before *Black's 25<sup>th</sup> move*, unless it is a case of repetition.

**Chief Arbiter Discretion:** In the event of an unexpected occurrence, the Chief Arbiter reserves the right to make all decisions in conjunction with or on behalf of this championship.

**Withdrawal:** A player may withdraw at any stage of the event subject to notifying the Arbiter, else he/she will be considered as withdrawn/ treated as withdrawn from the tournament, else *Chief Arbiter* decision otherwise.

**Appeals Committee:** Before the commencement of the tournament, a Three Member Appeals Committee shall be formed by the organizers. All members and the reserves shall be from the different district/units. No members of the committee can vote on the dispute in which a player from his own district is involved. In such case(s) reserve member(s) shall take his place in the committee. The decision of the appeals committee is FINAL and BINDING on all players concerned.

**Protest:** Protest if any, against the decision of the Chief Arbiter shall be made in writing with a protest fee ₹1,000/- within 30 minutes of occurrence of the incident. The amount shall be refunded if appeal is upheld. The decision of the appeals committee is FINAL AND BINDING on all players concerned.

**Disqualification:** No player shall leave the venue before the Prize distribution function without the permission of the Chief Arbiter.

**State Qualifiers :** Top four (4) players and will participate in the upcoming Senior National Women Chess Championship 2024”.
